The surveillor is responsible for collecting timely and accurate data on cases and controls, and meeting the project goals and priorities set forth by the CPNDS Network; building effective working relationships with clinicians at London Health Sciences Centre, and to conduct patient enrollment, clinical data collection, maintain quality medical documentation on research subjects, and clinical classification and characterization of adverse reactions.
