It is a unifying demand from governments, hospitals, patients and physicians. LHSC has begun to implement the American College of Surgeons National Surgical Quality Improvement Program (ACS NSQIP). A researcher is required to investigate evidence related to quality and best practices, which will lead to initiatives to improve patient access, flow, safety, outcomes, processes of care and patient experience.

General duties and responsibilities include:

- Focus on knowledge translation, health economics, and change management: investigate best practices and evidence related to quality, integrate research, theory, NSQIP data, and practical knowledge; make recommendations on improving surgical safety and practice at the organizational, departmental, and divisional levels; understand, estimate, and explain the economic implications of changes in practice; develop, implement, and evaluate quality improvement initiatives, processes, and outcomes related to surgery.
- . Develop, write and submit clear and compelling grant proposals related to quality and best practices.
- · Access the NSQIP community of practice to understand comparative data and practices; research and identify improvements needed locally.
- Develop strong working relationships with leadership, physicians, allied health personnel, and programs (e.g., Infection Control, etc.) to promote a multidisciplinary
 approach to quality improvement and to define opportunities for collaboration. Provide education and training related to quality improvement initiatives.
- Facilitate ongoing quality improvements using risk-based methodology while maintaining compliance with LHSC processes and policies. Identify inconsistencies
 or failures to comply with practices and processes related to quality improvement initiatives.
- Analyze trends in data before, during, and after implementation of quality improvement initiatives
- Work with NSQIP SCRs to mine data for areas requiring improvement. Provide guidance and training as required to ensure quality data collection.
- . Provide regular updates to the VP Surgery Services and the Chair/Chief, Department of Surgery. Present at leadership and department meetings, as required.
